- 3. That the position of Interlibrary Loans/Bookkeeper will be replaced with the re-titled position of Manager, Collections and Community Engagement.
- 4. That the Manager, Collections and Community Engagement duties will include:
 - a. Overall responsibility for collection, future collection strategy, interlibrary loans and collection development.
 - b. Development of presentations and outreach to the Town of Parry Sound, contracting municipalities, community organizations and other potential donors.
 - c. Presentations to all groups, particularly the municipalities will involve both the Manager and the CEO.

 - e. In the absence of the CEO the Manager will serve as second in command and will fill the CEO role as required.
- 5. That the candidate identified in HR Committee Closed meeting session will be offered the position of Manager, Collections and Community Engagement with employment beginning November 28th, 2022 (or soon as they are available.)
